The House approved the renewal of Jist of AMAs for the year 2022 with addition of above New AMAs in the Jist. The Chairperson also requested Dr. Ankit Aggarwal, Joint Secretary to go through the Jist of AMAs and make efforts to add willing Heart Specialist & Endocrinologists to the Jist AMAs.

### 3. Increase in Registration Charges of AMAs:

Sh. Manjit Singh told the house that Registration Charges of Rs.750/- were being charged for renewal of AMAs and Rs.1000/- were being charged for New AMAs as Registration Charges. The Registration Charges were discontinued vide minutes of CGEWCC meeting dated 10/12/2020.
